## Historical Sketch

The Anderson family lived in El Paso between 1898 and 1956. Family members included Rowland, Paul, Lila, and James Anderson. The family owned several mines in Mexico during the early twentieth century. The Anderson family was also involved in mining enterprises with the Dale brothers and Felix McDonald.

The mines referred to in this collection are in the Iturbide district of the Mexican state of Chihuahua. More specifically, they are located in the Santa Eulalia municipality and mining district, an area well known for its rich sources of silver and lead, and the Aldama district.

## Scope and Content Notes

The records date 1898 – 1953 and contain maps, titles, testimonies, and receipts. The mines mentioned are the Santa Fe, Cuba Annexas, San José, Magdalena, Santa Elena, and the El Mar. Individuals mentioned in the documents include Rolando Anderson, Lila F. Anderson, James H. Anderson, Paul H. Anderson, Magdaleno Acosta, Francisco Porto & Associates, and C. G. Leolell. The records relate to the purchase and sale of mines in the state of Chihuahua by the Anderson family.
